Subject: Objection to the Issuance of a Telecommunications License to a Satellite Provider

Dear Chairman Molina,

We write regarding the application for a class license by Starlink Belize LLC (Starlink) to provide internet services in the entire territory of Belize as found in the Amandala newspaper of October 11, 2024. We express concern over this application and hereby formally object to the potential issuance of a license to Starlink within our country's telecom market. While we appreciate the regulator's commitment to enhancing connectivity, we believe that the introduction of a satellite provider, especially within a market with a small population, could have significant negative impacts on the existing telecom ecosystem.

1. Broadband Coverage

Currently via BTL the nation boasts more than 90% broadband coverage with FTTH technology and mobile coverage stands at over 95%, a testament to the considerable investment and continuous effort made by BTL. Over the past 10 years BTL has invested over \$300 million dollars and Belize was the first in the region with an LTE-Advance network and the first with country-wide coverage with FTTH since 2017 in this region. These figures represent the foresight in fulfilling the core mandates of both the government and the telecom sector in ensuring connectivity and in improving the lives of our citizens while stimulating economic growth. Introducing a satellite provider in such a highly saturated market would offer minimal additional coverage benefits while duplicating existing services.

2. Ultra-Competitive Market Dynamics and Sustainability

The telecommunications market in Belize is already highly competitive, with 16 operators (PUC Website) contending for a share in a population of less than 400,000. The introduction of an additional player, particularly one with extensive financial backing, would distort this delicate balance and lead to unsustainable oversaturation in the marketplace. This can result in undermining long-term investments in local infrastructure and service quality. Price wars and reduced margins will lead to reduced investments in local infrastructure, impairing long-term service improvements and coverage expansion projects, and ultimately place the country at risk in its technological development roadmap.

3. Data Sovereignty Concerns

Starlink operates global networks thus inherently pose challenges related to data sovereignty. This is because significant amounts of local data could be routed and stored outside national boundaries which can be subject to foreign laws and regulations. This raises serious concerns about data sovereignty, national security, privacy laws and the security of national communications. The country has recently prioritized the safeguarding of national data and allowing Starlink to operate could undermine these efforts by compromising data governance and regulatory oversight.

4. Employment Impact on Local Workforce

The telecom industry is a significant employer of skilled and semi-skilled labor within the country contributing significantly to Belize's economy. Local operators support a robust workforce, both directly through employment and indirectly via partnerships with contractors and service providers. The entry of Starlink, which typically operates with little to none on-the-ground personnel, will result in a substantial reduction in demand for local telecom workers, thereby impacting employment and economic activity in the sector.

5. Infrastructure Investment Incentives

BTL has invested hundreds of millions of dollars in countrywide infrastructure with over 2,000 kilometers of backbone and distribution fiber, over 170 cell sites and 13 customer service centers to deliver widespread, reliable connectivity, including remote and underserved areas. A satellite provider, by contrast, does not require local infrastructure investments, which would disincentivize continued investment in the national broadband and mobile networks due to fiscal reduction. Reduced infrastructure investment would hamper long-term growth and innovation to Belize.

6. Impact on Investment by GOB and SSB

The Government of Belize (49%), The Social Security Board (34%) and over 1,500 small Belizean Shareholders have entrusted substantial funds as investments in BTL. The decrease in revenues and profitability from additional oversaturation will erode the investment the country has made in the National Telecom. The decrease in dividends would have an adverse impact on the entities and citizens who are once again beginning to receive benefits from their investments.

We respectfully recommend that Starlink be encouraged to partner with an existing licensed Internet provider acting as its reseller, as this model has already been successfully implemented in other countries.

We strongly believe that the current telecom market has successfully met the connectivity needs of the overwhelming majority of our population and that the introduction of a satellite provider would yield minimal public benefit while posing significant risks to national investments, national employment, data sovereignty, and rob BTL of scarce capital needed to invest in the technology space to ensure and keep Belize at the technological forefront. Considering these concerns, we respectfully request that the





regulator prioritize the sustainability of the existing telecommunications ecosystem and reject the class license application.

We look forward to engaging further on this matter and provide any additional data or insights as necessary.

Subject: Objection to Starlink's ISP Application in Belize

Dear Members of the Public Utilities Commission,

As a registered professional engineer specializing in Telecommunications and Electronics and as a telecommunications worker, I am writing to express my concerns regarding Starlink's application to offer services in Belize. While satellite-based internet can be beneficial in remote and underserved areas, this approval may introduce serious technical, economic, and market-based challenges to our country's telecommunications sector.

From an engineering perspective, Belize's telecommunications operators—especially Digi—have invested in fiber-optic and mobile network infrastructure, which adequately meets coverage demands in most areas. The entrance of Starlink into the market could result in unfair competition to local providers. Digi, being majority-owned by the government, plays a critical role in generating revenues that contribute to national development. Reduced revenues due to increased competition from Starlink would likely weaken the company's and the government's financial capacity to invest in future telecommunications improvements.

The above concerns align with actions taken by the French regulatory authority (Arcep), at one point which revoked Starlink's license due to market disruption concerns and vertical integration risks [1]. Likewise, the U.S. Federal Communications Commission (FCC) recently flagged anti-competitive behavior after Starlink achieved control of nearly two-thirds of all active satellites in orbit, warning that this monopoly limits competition and long-term sustainability in the telecommunications sector [2].

From a technical viewpoint, while Starlink's satellite services are appropriate for remote regions, terrestrial infrastructure such as fiber-optic networks offer better speed, lower latency, and higher reliability. Therefore, in the absence of implementing a moratorium to better evaluate the various risks highlighted, I propose that Starlink be restricted to areas

where existing providers cannot currently or feasibly offer coverage in the future. This approach ensures improved connectivity and fair access to Belizeans without undermining the investments made by local operators or jeopardizing economic stability.

The approval of Starlink's application without restrictions could lead to job losses within the local telecommunications industry and weaken Belize's economic framework. I urge the Public Utilities Commission to prioritize local development and limit Starlink's presence to areas where it can complement rather than disrupt Belize's existing networks.

**RE: SUBMISSION OF OBJECTION TO TELECOMMUNICATIONS LICENCE APPLICATION
BY STARLINK BELIZE, LLC**

We write on behalf of The Belize Communications Workers Union Executives and its members (hereinafter referred to collectively as “**BCWU**”/ “**We**”/ “**Our**”/ “**Us**”/ “**BTL Employees**”) and refer to the captioned matter.

The BCWU wish to express our concerns and objections to the Telecommunications Licence Application submitted by Starlink Belize, LLC (“**Starlink**”), as published in the Friday, October 11, 2024, issue of The Amandala newspaper. The BCWU believes that if the Starlink application is approved, it could have significant negative impacts on the telecom industry, the broader community, and current and future job security in Belize.

As BTL Employees working in the telecommunications sector, the BCWU believes it is our responsibility to participate in this process and therefore take this opportunity to present to the Public Utilities Commission (“**PUC**”) our concerns with the Starlink application if approved by the PUC. Our concerns with the Starlink application if approved by the PUC are itemized below.

A. Threat to Job Security and Local Employment

We are deeply concerned that allowing Starlink to enter into our already saturated telecom market could undermine the job security of local

employees at Belize Telemedia Limited (“**our Company**”/ “**BTL**”) and other Service Providers in Belize. Our Company has embedded a culture that recognizes Return on Assets (“**ROA**”) and Return on Equity (“**ROE**”) as important metrics to guide decision-making in the investment to BTL Employees. Extensive investments have already been made in our Company’s network, infrastructure, and future expansion plans which have created and continues to provide Us with job security. Most importantly, should the PUC grant Starlink a Class Licence, it is highly probable that our Company will find it extremely challenging to achieve its planned ROA and ROE. This would have serious financial implications, forcing our Company to reevaluate its existing and planned people costs. Starlink, with its satellite-based model, does not offer the same commitment to local employment as our Company and other Service Providers, leaving many of Us and others in the telecom industry vulnerable to job losses if Starlink is granted a Telecommunications Licence.

B. Impact on Government Investment and Employee Benefits

We are particularly concerned that a decrease in revenues due to Starlink’s market entry will negatively impact the investments made by our Company’s major shareholders, the Government of Belize (49% ownership) and the Social Security Board (34% ownership), respectively. As BTL Employees, We are direct beneficiaries of these investments, either through services provided by the Government or through Our pension funds. A decline in revenues could harm these vital services and financial support systems.

C. Market Collaboration

Starlink’s proposed entry into the Belizean market, while more suited to rural areas, presents an opportunity for collaboration with local providers such as our Company. BTL is open to fair competitive practices and welcomes the potential for BTL to act as a reseller for Starlink in those regions where BTL currently does not provide coverage.

As it stands, BTL’s fiber-to-the-home broadband connectivity covers 90% of homes and businesses countrywide. BTL have made extensive investments already in its mobile and fiber networks, alongside future expansion plans. For the marginal difference in coverage, particularly in rural areas where BTL is currently unable to, We do not oppose Starlink accessing these areas. However, We respectfully request that the model Starlink has utilized in other markets, where local service providers act as resellers, be adapted

here in Belize. This would ensure balanced competition and continued local involvement.

Additionally, BTL has established a robust redundancy link and truck rolls system to ensure connectivity during incidents. In contrast, Starlink's satellite-based model lacks the foregoing essential features, which could compromise employment longevity, service quality, and reliability.

D. Displacement of Skills

As employees of a local telecommunications company like BTL, We value Our specialized skills that enables Us to quickly maintain and restore mobile and fiber services during incidents. Should Starlink enter the Belizean market as proposed, the highly technical and specialized skills of BTL Employees, which are unique to the telecom sector, may not be easily transferrable to other industries. While telecom employees may have general skills like problem-solving, analytical thinking, and technical aptitude, these might not be sufficient to qualify them for roles in other industries without additional training or experience. This could further destabilize Belize's already fragile economy and social system.

E. Lack of Investment in Local Communities

We believe that local telecom service providers are crucial to the long-term growth and development of our communities through employment-related programs as well as sponsorship and community relations. Our Company directly contributes to local economies, invests in infrastructure, and creates employment opportunities through scholarships and internships. We anticipate that Starlink's satellite-based approach will bypass these local investments, leading to reduced development and less support for youths, schools, prospective applicants, local businesses, and services.

F. Data Sovereignty concerns

Starlink's data centers are primarily located outside of Belize, meaning Belizean users' data would be stored and processed on foreign servers. This potentially subjects the data to the laws and regulations of those jurisdictions making it difficult to enforce Belizean laws or regulations in case of legal disputes or data breaches. Additionally, there is also a risk that foreign governments could also potentially gain access to Belizean users' data stored on Starlink's servers, violating local privacy laws. Belizean authorities may have limited oversight of Starlink's data practices, increasing the risk of unauthorized access. The transfer of Belizean data to

foreign servers raises concerns about data localization requirements and potential foreign surveillance or censorship. Ensuring Starlink's compliance with Belizean data privacy laws, like the Data Protection Act, could be challenging given its foreign operations.

We, urge the PUC to carefully consider Our concerns as part of the application for a Telecommunication Licence to Starlink. The risks to local jobs and community well-being are too significant to overlook. We are passionate and committed to the future of our industry and the communities We serve, and We ask that Our concerns be given careful consideration during the PUC's review process.

I'd like to declare my objection to the gazette APPLICATION FOR A TELECOMMUNICATIONS LICENCE NOTICE concerning Starlink Belize LLC from 11 October 2024. It is my sincere position that this company's objective does not align with the best interests of information and telecom workers in this country. Primarily, as I understand it, this company's infrastructure is not one that is or will ever be something that supports the same number of jobs and careers that currently exist in telecom in Belize. If this company is allowed to pursue its profit motive in this country, its growth could directly correlate to a decline in available jobs for workers in telecom that would not be offset by the jobs Starlink itself would provide. The nature of its satellite based main infrastructure is certainly not something that can offer work to line workers from our ground teams who may find themselves without jobs if Starlink gains a significant majority of market share. Additionally, we should strongly consider what negative economic effects Starlink may have on a country that has a national telecom. This sort of disruptive technology is not one that drives growth for the rest of the country but will instead lead to an export of once domestic revenue. To be clear, as a worker in the telecom industry I believe that change is the nature of our industry and many changes that I have witnessed in my 25 years have been for the benefit of all. Yet not all change and shifts in market share are inherently for the benefit of Belizean workers or consumers. This is why I must firmly object to this particular change as the disruption is not one that will ever benefit our country. Please consider that in this case, the personal benefit of each of us is also the long-term collective benefit of all of us. There is no growth that can come from this company. In regard to Starlink, there is no entrepreneur that will help build this country's infrastructure, and there is no exceptional Belizean that will get their chance to shape this country for the better. We write to express our concerns regarding the potential licensing of Starlink Belize LLC (Starlink) to operate in Belize as per application for a telecommunications license to provide internet services in the Amandala Newspaper page 18 dated October 11, 2024. We write as the key stakeholders in the telecommunications sector invested in the industry's growth and the nation's digital future. We see this application posing significant industry challenges that warrant thoughtful consideration and our objections are based on the following points:

1. Undermining National Infrastructure Investments

Reliable telecommunications services are crucial for the national security and the seamless operation of businesses. The telecommunications industry in Belize has made substantial investments in the hundreds of millions of dollars to ensure continuous service availability and access to the latest technology. This also includes the establishment of two geographically diverse redundant IP transit routes.

Enabling Starlink to operate in Belize will undermine these investments by diverting customers away from services that contribute to the resilience of our national infrastructure. Belize has a small population distributed over a large land mass in urban pockets. This results in a high capital investment model in an economy with GDP per capita of \$6,500 USD which is half of the world's average.

2. Erosion of Industry Profits and Impact on Rural Expansion

Introducing another player into an already ultra-competitive market will further erode profits for local Internet providers. This financial strain will diminish revenues in the industry's capacity and of essential capital to invest in rural expansion and adoption of new technologies, hindering efforts to bridge the digital divide and our collective goal of nationwide connectivity. Additionally, erosion of industry profits will impact adversely the investments made by Government of Belize with a 49% ownership of BTL and Social Security Board owning 34%.

These potential adverse impacts would impact directly the citizens of Belize given the diminished dividends to these institutions.

3. Potential for Market Dominance

Starlink, backed by the SpaceX Conglomerate, has the potential to dominate the Internet market in Belize due to its ability to offer services directly to consumers at lower prices even subsidizing below cost to gain market share. This poses a risk of creating an uneven playing field, disadvantaging local providers who have invested heavily in infrastructure to deliver comparable services. This could lead to a scenario, ultimately harming consumer interests in the long run.

4. Cherry-Picking Customers

The pricing model of approximately \$270 USD for the antenna/router kit and \$23 USD for monthly Internet packages (based on Nigerian pricing), Starlink is likely to attract businesses and high-end residential users. These customers represent about 60% of the local Internet providers' customer base. The loss of these customers would lead to substantial revenue declines for the local providers, while rural communities may still find these prices unaffordable.

5. Lack of Infrastructure Investment in Belize

Over the past decade, individual licensees and class licensees have invested approximately \$400 million in broadband and mobile Internet infrastructure in Belize, with plans to invest an additional \$150 million over the next five years to extend services to unconnected regions. In contrast, Starlink plans to leverage its existing assets without making significant infrastructure investments locally, leading to an uneven competitive landscape.

6. Implications for Foreign Currency Reserves

Granting Starlink a telecommunications license will mean a significant portion of its earnings will be repatriated to its parent company abroad, leading to an unnecessary outflow of foreign currency. Local providers, conversely, require foreign currency primarily for purchasing equipment that enhances services within Belize thereby contributing directly to the growth of the national economy.

7. Minimal Contribution to Local Employment

Starlink's business model involves direct customer contracts and self-installation kits, requiring minimal local staffing. This contrasts sharply with local operators who collectively employ about 1,000 personnel for installations, maintenance, and customer service, significantly contributing to local employment.

8. Affordability Issues for Rural Customers

The initial cost of \$300 USD for the starter kit places Starlink's services are out of reach for most rural customers, the very demographic that could benefit most from Internet access. This raises concerns about the provider's ability to contribute meaningfully to Belize's national connectivity goals.

9. National Security and Data Privacy Concerns:

In allowing this foreign entity to control part of the communications infrastructure, this will raise issues regarding data sovereignty, security risks, and compliance with local data protection laws in Belize.

Considering the above, we respectfully request that the PUC denies Starlink's application for a telecommunications license to operate in Belize. We believe that protecting the investments and viability of local Internet providers is in the best interest of Belize's economy as it ensures continued investment in infrastructure, technology, and services that benefit all our citizens.

We look forward to further engaging to discuss these concerns in more detail and work collaboratively towards a solution that benefits all stakeholders.



RE: Petition Against Telecommunications License Application by Starlink Belize, LLC

We, the undersigned employees of Belize Telemedia Limited (“BTL” or “Company”) wish to collectively express our concern and objection to the telecommunications license application submitted by Starlink Belize, LLC (“Starlink”), as announced in the Amandala newspaper on October 11th, 2024. We feel that this application if approved, could have significant negative impacts on our industry, the broader community, and our current and future job security.

As employees working in the telecommunications sector, we believe it is our responsibility to participate in this process by raising the following concerns:

1. Threat to Job Security and Local Employment

We are deeply concerned that allowing Starlink to enter our market could undermine the job security of local employees. Our Company has embedded a culture that recognizes Return on Assets (ROA) and Return on Equity (ROE) as important metrics to guide decision-making in the investment to BTL employees. Extensive investments have already been made in our BTL network, infrastructure, and future expansion plans which have and continue to provide us with job security. Most importantly, should the PUC grant Starlink a license it is highly probable that BTL will find it extremely challenging to achieve its planned ROA and ROE and the financial implications will be significant as the Company will be forced to look at the existing and planned people cost. Starlink, with its satellite model, does not offer the same commitment to local employment, leaving many of us and others in the industry vulnerable to job loss.

2. Impact on Government Investment and Employee Benefits

We are particularly worried that a reduction in revenues due to Starlink's market entry will negatively affect the investments made by the Government of Belize (49% ownership) and the Social Security Board (34% ownership). As employees of BTL, we are direct beneficiaries of these investments, either through services provided by the Government or through our



pension funds. The decline in revenue could jeopardize these vital services and financial support systems.

3. Market Collaboration

Starlink's proposed entry into the Belizean market, while more suited to rural areas, presents an opportunity for collaboration with local providers like BTL. Our Company is open to fair competitive practices and welcomes the potential for BTL to act as a reseller for Starlink in those regions where we currently do not provide coverage.

As it stands, Digi's fiber-to-the-home broadband connectivity covers 90% of homes and businesses countrywide, with extensive investment already made in mobile and fiber networks, alongside future expansion plans. For the marginal difference in coverage, particularly in rural areas where BTL is unable to provide service at this time, we do not oppose Starlink accessing these areas. However, we respectfully request that the model Starlink has utilized in other markets, where local providers act as resellers, be applied here in Belize to ensure balanced competition, and continued local involvement.

Additionally, BTL has established a robust redundancy link and truck rolls system to ensure connectivity during incidents. In contrast, Starlink's satellite model lacks the foregoing essential features, which could compromise employment longevity, service quality, and reliability.

4. Displacement of Skills

As employees of a local telecommunications company, we take pride in our acquired skills that enable us to maintain and restore mobile and fiber services during incidents. Should Starlink enter the Belizean market as proposed, the highly technical and specialized skills that employees of BTL currently possess will be eroded, as they are not easily transferable to other industries in our Belizean market. This will certainly degrade an already strained economic and social system in our country.

5. Lack of Investment in Local Communities

We believe that local telecommunications providers are essential to the long-term growth and development of our communities through employment-related programs as well as sponsorship and community relations. Our Company contributes directly to local economies, invests in infrastructure, and creates employment opportunities through scholarships and internships. We anticipate that Starlink's satellite-based approach will bypass these local investments, leading to reduced development and less support for youths, schools, prospective applicants, local businesses, and services.

Conclusion

We, the employees of BTL, urge the Belize Public Utilities Commission to seriously consider our above points as part of the application or telecommunication license to Starlink. The risks to local jobs and community well-being are too great to ignore. We are passionate about the future of our industry and the communities we serve, and we ask that our concerns be given careful consideration as part of the review process.

We have attached the signatures of BTL employees in support of the contents of this letter.

Belize Business Bureau objects to the granting of a telecommunication service provider license to Starlink Belize LLC and request that their application is rejected. The BBB, as the nationally chartered productive sector organization confirms that the losses will far outweigh the gains.

Deterioration of National Investment: Digi \$100 million in FTTH will not be recovered and this will affect Social Security and government investment in a constitutionally established company. This means less return for the contributors' fund. Profits from this new provider will be repatriated—a return to colonial economic imperialism.

Threat to Sovereignty and National Security: Personal internet data will be owned by the foreign provider with no control by the regulatory agency. Citizens have a right to their data and how it is used. Today there is high market penetration with national coverage at 95% by Digi Mobile alone, so the new entrant will be motivated to lower prices to drive out the two local providers, our national investment in telecom infrastructure will be lost. A nation without control over its communication is exposed and its sovereignty threatened. The new provider will be out of reach of national compliance and regulatory control.

In India and Africa Starlink, a unit to SpaceX is a significant threat to local ISP and telecoms who have spent millions is laying cables and building mobile towers. The Association of Telecommunications Companies in Nigeria have called for sanctions to Starlink's unapproved subscription price increases. **FFCC Chair Jessica Rosenworcel called Starlink "a monopoly"** with it 7,000 satellites. She further added, "Our economy does not benefit from monopolies." The regulatory body, Indonesian Competition Authority announces an investigation into PT Starlink Services Indonesia (Starlink) over alleged unfair competition.

BBB was at the forefront in the battle to get BTL to provide affordable VOIP. It continued its opposition to monopolies (butane) and it is once again recommending to the People's Constitution Commission that fair competition becomes a protected right in the new constitution.

Elon Musk, founder of X com merged with Confinity and was a part of the PayPal Mafia. The founder of PayPal, author of Zero to One, Peter Thiel and Musk, the founder of SpaceX share the philosophy that "striving for a monopoly, is crucial for a business's success." SpaceX has established itself as a monopoly within its advanced technologies and market control (Chinese lithium batteries), so much so, that buyers no longer own their electric car but are paying for a subscription.

Starlink, a unit of SpaceX is a giant with no cage. Forewarned is forearmed.

Subject: Social Security Board's (SSB) strongly objects to the granting of a Class License, as Internet Service Provider (ISP), to Starlink Belize LLC.

The Social Security Board (SSB), established in 1981, has at its core, the mandate to provide social insurance for employed persons; as a result of the growth in population compounded by an increase in number of benefits, the SSB is required to explore investment avenues that will contribute to the long-term growth and sustainability of the fund. In this regard, SSB is a significant shareholder in Belize Telemedia Limited, owning 34% of the Company. Thus, any issue that affects BTL, is also felt by the SSB and ultimately our beneficiaries, which are the working people of this country. SSB's response therefore places greater emphasis on the social impact based on financial and market analysis, rather than on the technological impact of satellite services.

These could have more impact upon the market share movements than the material pros or cons of the technology.

- a. SSB's primary interest is, as a significant Telemedia shareholder, maximizing revenue and stemming risks to positive revenue growth from this investment.
- b. This investment contributes to the continued growth in reliable and sustainable internet services, creating greater efficiencies in the way we do business in Belize and engagements with countries across the globe. This reliability results in increased uptake of Telemedia's Internet and other services bundled for a greater business experience.
- c. SSB is also a consumer of Internet Service Provider (ISP) services and the potential impact upon resiliency and business continuity and alternative paths to its platform that has evolved into a significant cloud presence. SSB relies heavily on a stable and available internet for its core operations. Maintaining reliability and availability of its services requires not only stable architecture but also redundancy.
- d. The financial analysis and security of investments in its Associate, Belize Telemedia Limited, contributes to ensuring the long-term sustainability of the Social Security Scheme which allows for timely provision of benefits to the people of Belize. This year our investment in BTL generated \$3.8M.
- e. Satellite internet is very convenient and allows for mobility and accessibility in remote areas. On the other hand, and with all other things equal, a wireless connection is less stable than a wired connection.

- f. Wireless connections are subject to various forms of interference. The characteristics of a satellite service make it technologically advantageous, if the primary need is remote access, and intermittent degradation in performance is not a significant concern. Just as with solar power concerns in Belize, satellite-based services will have to contend with the high percentage of cloud cover experienced in Belize.
- g. Cloud cover can degrade satellite service, at times significantly. Nevertheless, an exodus of consumers over to the new service, even for a temporary period, will take a toll on the market share and revenue of the existing providers and their shareholder,
- h. In essence, granting of the License to Starlink will result in lost market share for Belize Telemedia Limited that would lead to a reduction in investment income to the SSB.

Good Morning,

Whilst not a fan of Elon Musk, I'm writing in support of Starlink's application to provide internet service here in Belize.

Situated nearly two miles from Sarteneja, Wildtracks is outside the range of both BTL and Smart for receiving internet – their antennae do not point in this direction. We therefore obtain our internet service from Stellar Links in Corozal. Whilst Stellar Links' service is generally OK, it does not have any emergency power back-up system in Sarteneja (or Corozal?), so whenever there is a power blackout, we lose internet service, as we do with bad weather conditions. As we barely have any telephone service here either, this leaves us without communication moderately often – as would worryingly be the case in severe weather conditions.

As a satellite system, Starlinks should remain unaffected by these factors and therefore be a highly reliable internet provider, especially in times of emergencies like hurricane events. If Starlinks is granted a license to provide internet service in Belize, Wildtracks will sign up for the service at the earliest opportunity – primarily to ensure that we retain communications in times of emergency, and secondarily throughout the relatively frequent power outages and inclement weather that plague our current access via Stellar Links. In all likelihood, we would retain our Stellar Links service – so Starlinks would be additional to, rather than replace our current ISP.

Thank you for the public notice of the application and the opportunity to offer comments. I am an active member of the QRP program. I'm currently renovating a property on the island of Caye Caulker. The property is not connected to the island's power, telecommunications, or water systems. I hope to eventually create an eco-friendly and sustainable business on this property and take advantage of the Retire and Invest program. However, this investment is much less attractive without a proper internet connection.

I've already built a large cistern to support my water needs and installed solar panels to help my power needs. But I need to find a way to solve the problem of a lack of internet connectivity. Enabling Starlink for properties like mine that can't take advantage of the infrastructure installed in Belize's more densely populated parts would be an excellent motivator for more investment. Given the price difference, there would be little incentive for people already connected to the local internet providers to switch to Starlink, thus resulting in no revenue loss.

The portable nature of the connections and the ability to take on a boat for trips around the coastland of Belize would also be very beneficial for tour operators. First off, I am a recently naturalized Belize citizen. I live full time with my Belizean wife and son in a remote area of Cayo. Although all three of us have either DigiCell or Smart cell phones, none of us can get a phone or internet signal at our home. For a while we were able to get internet service through Infinite, but tree growth blocked their wireless signal from Bengue almost a year ago. We are therefore in a dead zone, without the ability to contact emergency health, fire, or police services when we are home. We also have no electronic entertainment, no access to news and weather reports, and no ability to communicate with friends and family. This can be critical when the road to our home floods

I can't see how Starlink could negatively affect existing telecommunications in Belize. As you can see from below, I have an office in San Ignacio where I practice U.S. law over the internet. I use DigiCell at work, which is far less expensive than Starlink, and will continue to do so even if we were to get Starlink for our remote home.

I have a property in Belize where I would very much like good internet. The nearest Internet however is 5 miles away. Cell service only works with a repeater.

The critical point to get across is that Starlink is not competition to Belizean internet providers. Land based internet in towns is much cheaper, and probably better in capacity and latency. If quality land based internet were available I would not pay the Starlink premium. Starlink shines where these services don't reach. It actually helps local internet providers as they can focus on the denser populations and don't have to invest to services the sparse or geographically isolated locations. Those last 5% of customers are extremely expensive to service, so they are ignored, or heavily subsidized. Starlink will help rural Belize.
