The Government of Belize (GoB) is inviting expressions of interest from qualified developers for the Consulting Service for the Development of a Solar Photovoltaic Project in Belize. This initiative supports the country's renewable energy transition and energy security goals by promoting private sector participation in large-scale renewable energy projects.

The objective of this consultancy is to facilitate the development, financing, construction, operation, and maintenance of grid-connected solar photovoltaic (PV) plants with a total installed capacity of up to 80MW.

The Ministry of Finance invites eligible firms to indicate their interest in undertaking this consultancy. Interested firms should provide information demonstrating their qualifications and relevant experience to perform the services. Interested parties are hereby invited to submit an Expression of Interest package including:

- Company Profile: Description of experience, ownership structure, and key personnel.
- Summary of Past Solar PV or IPP Projects: Details on project capacity, location, role.
- Financial Capability Statement: Evidence of funding capacity.
- Project Approach: High-level plan for the development, financing, and integration of the solar PV plants.
